Dear Commissioner:

We write with respect to the Major Projects Development Program, a recently announced Department of Buildings (DOB) initiative that allows developers of certain projects the option to buy into a streamlined and expedited process with additional Agency staff resources and consultation. As organizations representing developers, lenders, builders and advocates of affordable and supportive housing, we would like to express our concern that the initiative is likely to exclude affordable and supportive housing and potentially create additional delays for projects that cannot afford to pay the additional fee. If expedited review is possible we suggest it is targeted to projects working to address the affordable housing crisis, in line with the Administration's priorities.

As a coalition of affordable and supportive housing advocates, we have all long articulated the importance of shortening project development timelines, to reduce costs and, even more importantly, to deliver these life-changing units to families and individuals more quickly. As we all understand, that need to do so is greater than ever as the city confronts record homelessness, rent burdened and overcrowded families, and affordable housing lotteries that regularly get tens of thousands of applicants for a few hundred units.

Streamlining and faster processes in filings, permitting, compliance, violation clearance and TCO and CO issuance at the Department have been a focus of our constituent members, and we reviewed the announcement of this new program with interest. It is exactly the kind of forward thinking that City agencies should be engaged in to tackle the housing crisis. Unfortunately, the fees (\$25,000 for affordable housing projects) and the size and scope thresholds will mean that these important projects largely do not qualify. Our non-profit developers in particular operate on extremely thin margins while providing projects that do more in terms of deep and permanent affordability. They will face insurmountable barriers in paying a fee even if their projects were to qualify.

Elements of this new program appear to be modeled after the Affordable Housing Unit at the Development HUB, a groundbreaking initiative that has been hugely important to our members. However, we feel that to the extent the Major Projects Developments Program goes further and offers even more, it should apply also to our developments, regardless of size and scope. In addition, it should do so without a fee, which for City-funded projects will essentially amount to one City agency paying another in the form of additional subsidy.

Beyond simply not having access to the consulting services and additional fast-tracking, a lack of inclusion from the program could be detrimental to the extent that staff resources dedicated to the Major Projects Development Program are not going to projects outside of the program, meaning further delays. At a time when housing is needed so desperately by so many, our City cannot afford to delay much-needed affordable and supportive projects while market rate and major commercial buildings get special treatment.

We applaud your mindset in reducing red tape and dedicating real resources to reducing development timelines, as well as for the special attention the Department has given to affordable and supportive housing in other areas. We simply want to see this exciting new initiative apply to all sizes of supportive and affordable housing, which we see as second to none in terms of public importance and transformational human impact.
