My name is Dawn Tolson and I am the executive director of Cecm and SAPO. I would like to welcome you to the Mayor's Office of Citywide Event Coordination and Management's hearing on his proposed St. Activity Permit Office Rule, amendments relating to the extension of Street Fair.

Of the street fair moratorium, a multi day, multi block St. Fairs.

Today's hearing will be conducted in accordance with the Charter City Wide Administrative Procedure Act, or Kappa.

Capital requires all agencies to conduct public hearings on proposed rules for the purpose of collecting comments from the public. Such hearings must take place no sooner than 30 days after the initial notice of opportunity to comment appears in the city record the notice of opportunity to comment on.

The rules prevented for consideration today was first published in the city record on October 21st, 2024.

Notice was also provided via e-mail to the Speaker of the City Council.

All council members.

All Community Board managers, members of the news media and relevant civic organizations.

In addition, CECM provided a copy of the notice to the New York City Rules website and posted it on our cecm website.

Cecm has been accepting written comments on these this proposed rule since publication of the notice in the city record and will continue to do so until the end of today.

You may provide written comments to us in person today or e-mail them to the address provided on that notice.

As a reminder, today's hearing will be will provide an opportunity for the public to provide feedback on the proposed rules.

As such, cecm officials in attendance will not answer any questions that are posed at the hearing. Our office will, however, carefully consider all written and oral comments it receives on this proposed rule.

Following such consideration, Cecm will issue a final rule by submitting a notice of adoption in the city.

Record the rule will go into effect.

Days from the date of publication, we will initially ask the public to testify in the order they were registered.

After that, we will ask other attendees to comment.

Please rate us the raise hand feature if you'd like to make a comment when testifying, please provide your name and affiliation and speak slowly and clearly so that your statement can be accurately recorded.

You will have 3 minutes to provide your testimony.
